## 3. Discuss Improvement Strategies for the Education Committee

#### a. Communication:

- i. We are currently facing a fabulous problem: a large number of people are interested in collaborating and participating in the educational opportunities provided through the Coalition.
- ii. Alejandra has received several phone calls and emails from people who are upset with the decisions being made by the Education Committee- these individuals have all been told that the Educ. Committee is composed of a group who votes on all decisions affecting or related to the Educational goals and objectives of the Coalition. If someone has a concern, please bring it to the Education Committee or the Steering Committee for further discussion. –All decisions are included in the monthly minutes.
- iii. There are several individuals within the Coalition with very strong personalities. These individuals have often times clashed with one another. We should all watch the way we speak to others.
- iv. Our mission is to collaborate: we need to do so by using and modeling compassionate communication. We all need to work on improving our communication, especially in front of new Coalition members and caregivers.

# b. Participation in Conferences: Exhibitors, Speakers, and Respite

- i. In order to be an exhibitor and/or speaker: you must be an active member of the Caregiver Coalition- this means that you must attend at least 6 of the 12 monthly meetings. We track attendance because it comes up and we have to set membership standards. There are no membership fees – therefore, we are all in it together.
- ii. Alejandra and Joanne are currently working on developing policies and procedures for the Speaker's Bureau. Once they have a draft version of this, it will be taken to the Education Committee and finally the Steering Committee for approval.
- iii. If the planning committee is interested in a topic and/or speaker that is NOT part of the Caregiver Coalition's Speaker's Bureau, the Planning Committee must vote on this decision. The planning chair alone CAN NOT make this final decision.
- iv. Respite there will be a rotation with the agencies interested in providing this service in order to give everyone an opportunity to sponsor the Respite.
